Key Accountabilities	• Support residents by providing holistic person-centred care; hygiene and physical wellbeing • Support customers to maintain a high standard of personal care including intimate care, hygiene, and physical wellbeing. • Responsible for the security and safety of the building at night in line with Trust policy • Headcount of residents during the night checks as prescribed in Trust policy • Carry out all emergency procedures including basic first aid as necessary in respect of accidents, illness and death. • Follow procedures to ensure health, safety and security. Report any damage or fault in equipment, furniture or fitting to the Home Manager • Administer medication in accordance with policies. • Support residents in the development and review of their personal wellbeing ensuring relevant changes are reported to the Head of Care. • Contribute and work collaboratively as a team member and establish good working relationships with colleagues, customers, professionals and visitors. • Undertake domestic chores through the night when all care related activity has been undertaken • Support residents to make, prepare for and attend appointments where required, • Ensure the household and rooms are kept clean and tidy e.g. making beds, vacuuming, mopping etc. involving customers where appropriate. • Ensure the health and safety of employees, visitors and residents in compliance with Health and Safety regulations and Trust policy.
